WHO WE ARE

Partners Health Plan is...

- A not for profit managed care plan that benefits to individuals eligible for both Medicare and Medicaid through the Fully Integrated Duals Advantage for Individuals with Intellectual and Developmental Disabilities (FIDA-I/DD) Demonstration.
- Lead by invested stakeholders family members and advocates with decades of experience in health care and in managing services and supports for people with intellectual and developmental disabilities (I/DD).



History and Development

- ➤ We are a specialized managed care initiative tracing our roots to the creation of the ARC (originally known as Association for Retarded Citizens) in the late 1940s
- In recent years, recognizing the sometimes fragmented delivery of services and supports and the lack of coordination between long-term services and health care for individuals with I/DD, the Downstate NYSARC chapters began evaluating approaches to *integrate the full continuum of care*
- ➤ The goal was to seamlessly and efficiently integrate physical and behavioral health services with other long-term services and supports such as habilitation
- ➤ The Downstate ARCs/AHRCs decided that the best way for parents to ensure the long-term security of their children was to participate in the development and implementation of a managed care program in the same manner as they had developed the other core components of habilitative care

TIMELINE

- ➤ 2012: PHP is incorporated in 2012 and granted a Certificate of Authority to operate a Managed Long-Term Care Plan (MLTCP)
- ➤ April 1, 2016: PHP FIDA program begins enrollment.
- ★ 2019 and beyond: PHP becomes an "early adopter" plan first offering Medicaid Managed Care without OPWDD services and then includes OPWDD services.

What Makes Us Unique

- Customized life plan for each member created within 60 days of joining the plan
- > High level of parent involvement on board of directors
- ★ Self advocate involvement in plan development
- Continuity of Care period
- ➤ Dual Care Team with a licensed RN/Social Worker as the leader*
- ➤ Robust I/DD centric network of medical providers
- ➤ Durable Medical Equipment (DME) Specialist to ensure that members get the medical equipment they need
- > Person-centered program designed to help members in achieving their goals

- Most of our medical benefits need no authorization or referral.
- ➤ We offer free, non-emergency private transportation for people living in the community to and from medical appointments.
- ➤ Our Care Coordination team includes a Care Manager, a Care Coordinator, you, your family, and other people important to you as part of the team which helps determine what benefits and services will work best for you and authorizing them for you.
- ➤ We have demonstrated success in improving health outcomes and happiness through our programs. (Telemedicine, Pharmacy Management, and Choose Health Rewards Program, PAL Program)
- ➤ Easier and faster access to services you need. (OPWDD Waiver Services, Self-Direction Budget Approval, etc.)
